FELLOW OF MPA APPLICATION

All pharmacists who belong to Montana Pharmacy Association (MPA) are invited to apply for Fellow of the Montana Pharmacy Association (FMPA) designation. The FMPA Award recognizes the recipient's achievements and dedication to the practice of pharmacy and the community. The distinction signifies the recipients' actions well beyond regular pharmacy practice. Qualifying applicants will receive an exclusive lapel pin, a certificate, recognition in the MPA Newsletter and an invitation to receive their award during the annual awards ceremony held during the MPA Winter CE Conference.

The fellowship is divided into three areas, all of which help define a well-rounded pharmacist. Applicants are required to earn points in 3 categories: I) Professional contributions, II) Public Service, III) Pharmacy Association Participation. A total of 100 points is needed overall with the minimum points met in each category to earn the fellowship. All points may be retroactively added from the beginning of an applicant's pharmacy career. Applicants must be a current member in good standing with MPA with a minimum of 5 years of membership post-graduation to be eligible.
