UPDATE FROM UM SKAGGS SCHOOL OF PHARMACY

In 2017, the University of Montana Skaggs School of Pharmacy, Montana Family Pharmacies (MFP), and the State of Montana Health Care and Benefits Division (HCBD) partnered to create a medication therapy management (MTM) program for HCBD beneficiaries. This led to the creation of the IPHARM Pharmacy, a licensed community pharmacy with MTM services, within the School of Pharmacy, a homegrown solution for MTM services for Montanans. Though the pharmacy does not dispense medications, it utilizes NDC codes created specifically for its services for reimbursement of the clinical services provided. IPHARM Pharmacy, along with MFP, have provided asthma and diabetes chronic disease management programs as well as traditional MTM services for this self-insured health plan since July, 2018.

The chronic disease programs are provided at no cost to the patients and administered over the phone. Quarterly check-ins are required to continue to receive program benefits. Participants are eligible for copay reductions on certain inhalers, no cost diabetes testing supplies, and assistance signing up for manufacturer copay coupons. Additionally, IPHARM Pharmacy is an excellent experiential site and provides many fourth-year pharmacy students with the opportunity to gain experience with MTM and chronic disease management. IPHARM Pharmacy has served as an APPE site for approximately 50 students since its inception. Historically, students have completed about 30-40% of the disease management check-in phone calls. One student said "this APPE was a great experience to improve counseling skills. I enjoyed getting to talk to patients every day and make meaningful recommendations to them. I think this rotation is a great learning opportunity." Another student said "I had a great experience during this rotation which provided flexibility to explore areas of interest and obtain some direct patient care experiences. All the MTM staff were a pleasure to work with and fostered a safe learning environment."

In May, 2021 a satisfaction survey was sent out to nearly 500 patients and responses were received from about 170 patients. The responses were overwhelmingly positive. Patients found the students and staff both "very knowledgeable" and felt that they "cared about their health and well-being". The majority of survey respondents stated the most beneficial part of the program were the services that address patient cost savings.

A measurable effect of the disease management programs at IPHARM Pharmacy has been medication adherence. Prescription claims data was analyzed 240 days before and after enrolling in a program. Both asthma and diabetes patients saw improvements in medication adherence associated with their respective disease state after enrolling with IPHARM. For example, before enrollment, patients had a medication possession ration (MPR) of 71.72% for metformin. After enrollment, the metformin MPR for these patients went up to 85.36%. There were also 21 patients with uncontrolled asthma who were not using a controller medication before enrolling in the asthma program. Once enrolled, a certified asthma educator (AE-C) evaluated each patient, consulted with their provider, and a controller medication was initiated.

To date, IPHARM Pharmacy has provided chronic disease management services for 959 patients and has completed over 8,000 program check in phone calls. As of January 2022, IPHARM Pharmacy has 522 patients actively participating in the disease management programs. ■



2022 MPA ANNUAL AWARD WINNERS

MIKE RIVEY- 2022 BOWL OF HYGEIA AWARD WINNER



The Montana Pharmacy Association announces that Mike Rivey of Missoula has received their prestigious, "Bowl of Hygeia Award." Mike is a PharmD with the Community Medical Center, Missoula, MT (PGY1 Residency Director) and retired from the University of Montana Missoula.

MPA Board Member JoEllen Maurer presented Mike with the Bowl of Hygeia Award stating, "Mike has demonstrated a level of commitment

that should be used as a model for others to follow." She added, "His accomplishments are many including serving as a faculty member for decades where he enriched the education of countless students both in the didactic and experiential settings."

Doug Allington who has worked with Mike for the past 30 years at CMC articulated the following which really puts Mike's clinical prowess in perspective: "The exceptional faculty member finds a way to create and sustain programs that are of such value that physicians will entrust significant portions of care to other professionals. Mike created pharmacy-based protocols, approved by physicians, which guided medication dosages to prevent clotting disorders such as strokes and pulmonary embolisms; maximized the effectiveness of antibiotics: reduced medication costs by timely substitution of oral medications for intravenous counterparts; and launched a pain management program for patients following orthopedic surgery. Publications describing the process and outcomes of these programs followed each successful program. Naturally, the educational experiences of pharmacy students have been enriched through observation and participation in each of these programs."

Maurer explained, "One of Mike's most notable accomplishments for the profession has been the development, supervision and management of the pharmacy residency program in Missoula. Mike was the first person in the state to achieve this hallmark accomplishment. Currently, there are over 20 pharmacy resident positions across the state and Mike was the inspiration."

The "Bowl of Hygeia" Award is presented annually by participating pharmacy associations in each of the fifty states, the District of Columbia, Puerto Rico, and the ten Canadian provinces. The first Montana Bowl of Hygeia was awarded in 1959 to John J. Downey of Butte.

JOSH MORRIS RECEIVES PHARMACIST OF THE YEAR AWARD



The Montana Pharmacy Association (MPA) is pleased to share that Josh Morris, owner of Elkhorn Pharmacy in Boulder, Silvertip Pharmacy in West Yellowstone and Whitehall Pharmacy has received the association's "Fitzgerald Pharmacist of the Year Award". Keaten LaBrel of the Montana VA Health Care System at Fort Harrison is this year's recipient of the "Excellence in Innovation Award."




PAUL BRAND, PHARMD, CPP, AE-C

BOARD OF PHARMACY UPDATES (pharmacy.mt.gov)

UPDATED NALOXONE STANDING ORDER WAS EFFECTIVE 1/1/2022

Montana's Standing Order 2022 for Naloxone, effective January 1, 2022, and program details are available on the Montana Department of Public Health and Human Services website at https://dphhs.mt.gov/amdd/naloxone/standingorder. Pharmacists need to use the updated Standing Order for dispensing naloxone pursuant to the authority outlined in 50-32-601 through 611, MCA.

SUMMARY OF FINAL RULE EFFECTIVE 11/20/21

The Board of Pharmacy finalized rule changes pursuant to MAR 24-174-74, amending various pharmacy rules, effective November 20, 2021. A summary of the amended rules is available on the Board's website and in the Administrative Rules of Montana (ARM). Topics include collaborative practice agreements, transfer of prescriptions, drug distribution in institutional/correctional facilities, drug kits, updates to scheduling of dangerous drugs (controlled substances), and changes to continuing education approved programs.

TECHNICIAN RATIO AND VACCINES

The Board of Pharmacy issued a proposed rule, MAR 24-174-78, to remove the 1:4 pharmacist to pharmacy technician ratio, provide for certain pharmacist-in-charge authority for staffing, and allow for licensees authorized to administer vaccines in their own scope of practice to assist pharmacists with vaccine administration. The comment deadline was February 11, 2022.

The Board's emergency rule, MAR 24-174-77, expired on January 11, 2022, and had removed the pharmacist to technician ratio for purposes of administering vaccines and tests, pursuant to federal authority, and allowed for similar use of other authorized licensees to assist in vaccine administration. The emergency provisions are no longer effective and the pharmacist to technician ratio is 1:4, as listed in ARM 24.174.711.

MEDICAL PRACTITIONER DISPENSING

Implementation of Senate Bill 374 (2021), dispensing of drugs by medical practitioners, is in progress and the application for registration is anticipated to be available by the end of February 2022. The Board of Pharmacy issued final rules for Medical Practitioner Dispenser registration and requirements, pursuant to 37-2-104(1) through (7), MCA. The fee schedule and new rules ARM 24.174.1801, 1802, and 1803, are available online.



WOULD YOUR DELIVERY/SIGNATURE LOGS PAAS AN AUDIT?

PAAS National® analysts are seeing a high rate of PBM audit results with invalid delivery and signature logs. We want community pharmacies to be aware of the issues to help avoid future headaches. Take the necessary steps now to ensure your delivery and signature logs are complete.

Many pharmacies question why PBMs bother requesting copies of signature logs/delivery sheets when concessions are in place allowing signatures to be waived during the Public Health Emergency. Not only do PBMs want some documentation to confirm the medication was dispensed, but they are also looking to see if their Return to Stock Policy was violated. PAAS Audit Assistance members can view the PAAS Return to Stock chart in the PAAS Member Portal for a summary of the major PBM timeframes. While obtaining physical signatures are waived; proof of dispensing is still required, and PBMs/auditors are more than happy to attempt recoupment when documentation is missing.

Manual signature and delivery logs have also been flagged for preprinted dates. Several PBMs do not accept these logs because they may not represent the actual delivery date. They require a date that reflects when the prescription was actually delivered. Additionally, pharmacies using manual signature logs must be sure to indicate the date received/sold and the date filled (or refill #). When sending in your manual logs for audit, be sure any dates listed at the top or bottom of a delivery sheet are included, and any irrelevant PHI is redacted.

PAAS TIPS:

- Complete delivery logs/manual signature logs should contain:
 - o Patient name
 - o Prescription number
 - o Date filled or fill number
 - o Date sold/received
 - o Facility name if delivering to LTC
 - Signature and credentials if appropriate, or indication of COVID-19 as referenced to PAAS Audit Assistance members in the August 2021 PAAS Newsline
- Check your current delivery logs for a blank date field that can be completed upon delivery
 - o Consult with your software vendor about updating your logs if needed
- Pharmacies using manual signature logs may want to consider using the PAAS National® Signature Logbook
- Self-audit your signature logs to ensure dates are included
