## WINNER: DONNA BEALL, PHARMD, FCCP, PROFESSOR WITH DEPARTMENT OF PHARMACY PRACTICE AT UM SKAGGS SCHOOL OF PHARMACY

Donna joined the faculty at the University of Montana Skaggs School of Pharmacy in 1997 and has spent the past 27 years exemplifying passion, commitment, and excellence in pharmacy education and community service. She has taught numerous courses, fostering a deep appreciation for the profession among her students, who have honored her with the Pharmacy Practice Teacher of the Year award six times and other accolades recognizing her contributions.

Her influence extends beyond the classroom. Donna has been recognized by professional organizations for her leadership and contributions to the pharmacy field. She was elected as a fellow of the American College of Clinical Pharmacy (ACCP) in 2007, serving as Montana's only ACCP fellow until 2023. She was also honored as an Academic Leadership Fellow by the American Association of Colleges of Pharmacy (AACP) in 2005 and as a Montana Pharmacy Association (MPA) Fellow in 2024.

During COVID-19, she helped immunize over 1,100 patients with All Nations Health Center.

#### IN EDUCATION:

Stuart worked alongside MPA boards and staff to establish the annual Winter Meeting. This Montana-specific event became a hallmark for pharmacy professionals to learn, network, and earn continuing education credits, embodying the unique spirit and dedication of the Montana pharmacy community.

#### IN LEGISLATION:

Stuart was at the forefront of MPA's legislative efforts, spearheading impactful bills that expanded pharmacists' roles and improved public health. Highlights include:

 Advocating for pharmacists to practice at the top of their licenses, with steady progress in areas like immunization laws, enabling pharmacists to provide vaccinations under collaborative practice agreements. Passing forwardthinking legislation such as the Client Pharmacist Practice (CPP) law in 2009, which paved the



way for pharmacists to deliver expanded health services.

- Championing pivotal pharmacy benefit manager (PBM) reforms, including:
  - o PBM Pricing Transparency (SB 211, 2015)
  - o Pharmacy Audit Integrity Bill (SB 235, 2013)
  - o Revised Reimbursement for Pharmacies (HB 276, 2017)
  - PBM Oversight and Licensure (SB 395, 2021),
     establishing state regulation of PBMs and granting
     enforcement authority to the State Auditor.
- Most recently, in 2023, he worked with MPA members to pass SB 112, a landmark bill creating new prescriptive, test-and-treat opportunities for Montana pharmacists.

In recognition of his extraordinary contributions, MPA is proud to announce the establishment of a scholarship in Stuart Doggett's honor. This scholarship will support the next generation of pharmacy professionals, ensuring that Stuart's legacy of leadership and commitment to advancing pharmacy continues to inspire and empower future healthcare leaders.

Stuart's unwavering dedication to the profession, his tireless advocacy, and his passion for collaboration have made him an invaluable ally to pharmacy professionals and patients alike. His work has left an indelible mark not only on MPA but also on the health and well-being of Montanans statewide.

#### **RECOUNT OF 2025 LEGISLATIVE SESSION**

The 69th Montana Legislative Session passed the motion to "sine die" on April 30th, 2025, 85 days into the session. This is 2 days earlier than last session and 5 days later than the 2021 session. After the slow start to the session due to internal party strife, both chambers gained momentum before each transmittal deadline and only worked Saturdays when those deadlines neared. During the first half of the session, there was a lot of frustration with legislative staff as there were a lot of bills that had been requested that were delayed making it back to the legislators, including several bills with which MPA was involved. Legislative staff worked overtime and through the weekends to get the bills delivered to make the deadlines. Overall, there were 4,495 bill draft requests (4,643 last session, 2218 in 2013) and 1,765 bills introduced (1,698 last session, 1,187 in 2015). As of this writing, the Governor is still signing/vetoing bills so the final count of passed bills has not been finalized but 806 were headed to the Governor's desk. Last session, 885 bills were adopted compared to 484 in 2011. Of these, MPA was tracking/monitoring roughly 250 of these pieces of potential legislation.

In continuation of last session, the majority party experienced a lot of internal struggles to maintain and complete several of their goals for the session. This started during the first week on the Senate side, with several republican legislators protesting the makeup and necessity of a proposed committee. These republicans, eventually called "the nine", would continue to oppose majority leadership on several initiatives, thereby decreasing the overall power of the majority party. In addition, the legislator that was the Senate president last session was involved with suspicious contracts prior to the session and the majority party help proceedings to have him expelled from the legislature, but did not have the overall support, but were successful in censuring him, and revoking his privileges from the senate floor, requiring him to attend virtually. Also, one legislator resigned during the first month, and was eventually replaced by his party.

Overall, there was much progress done on the goals set at the beginning, but the overall effectiveness is still being debated. Among the bills passed included Medicaid Expansion, the largest income tax cut in state history, property tax relief, and an historic investment in education. Much of this was with the support of the Governor's office, which was in opposition of many of the more conservative republicans. There were several bills targeting healthcare, in addition to ones MPA was involved, including banning vaccines and fluoride (failed), allowing chiropractors

prescriptive authority (failed), and putting additional sideboards on insurance mandated prior authorizations (passed.) Overall, it was a successful session for our profession and in addition to passing groundbreaking legislation, we helped pave the way for future sessions. Healthcare professions throughout the state worked together more during this session than in previous sessions in memory. In fact, HB 740 may not have passed without the help of pediatricians, physician assistants, and nurses!

Once again, this session would not have been possible without the help of all of you. The grass roots efforts of our profession showed its strength, and it is because of your assistance we saw such success. A great appreciation goes out to everyone who helped by contacting their legislator!

#### **HIGHLIGHTS OF KEY BILLS**

HB 245 – Medicaid Expansion – PASSED! Removed the sunset for health insurance for a segment of low-income adults. There were several efforts to phase out Medicaid expansion and increase work requirements but those mostly failed. There is ongoing discussion federally that may affect the current program, but the current program no longer is affected by a state sunset.

HB 41 – Generally revise dangerous drug schedule – Passed!
Changes gabapentin from non-controlled to a Schedule V
medication. Takes effect October. One of several states to schedule
this medication. An inventory will need to be taken at each
pharmacy October 1 to comply with DEA requirements.

**HB 60 – Generally revise state auditor laws – Passed!** Extends the termination date of the prohibition against a pharmacy benefit manager or health carrier requiring federally certified health entities to identify 340b drugs.

**SB 456 – Revise professions and occupations laws regarding dispensing – Passed!** Allows persons other than the provider to dispense medications to patients (with offer to counsel.) We expected this prior to the session and did not oppose.

Various prior authorization bills – majority passed. We worked with several other healthcare professions in attempts to put sideboards on insurance companies requiring prior authorization on services. For pharmacy, PBMs are not allowed to require prior authorizations for "formulary generics." This was a compromise on language to get the bill passed. It probably neutralized most of the intent of the bill, but others were in favor of this language. More info

SR 49 - Confirm governor's appointees for board of pharmacy

**- Passed!** MPA supported the Governor's appointment of Paul Brand, Michelle Case, and Logan Tinsen. We were happy to support the Department of Labor and Industries (DLI).

**DLI initiatives – Continuation of red-tape relief efforts from 2023 - Passed.** While not directly affecting pharmacy, many of these efforts standardize processes within DLI. MPA was happy to support when asked/needed.

HB 794 – An act generally revising pharmacy laws – PASSED! MPA's primary bill for 2025 session. In combination with the Board of Pharmacy and DLI, this was passed without opposition. We appreciate the efforts our bill sponsor, Rep. Schomer and the DLI's staff – Sarah Swanson, Kevin Bragg, and of course, Marcie Bough. This bill removed the requirement for technician utilization plan and allows for technician practice under the direct supervision of the pharmacist. It also removes the requirement to notify the provider

when a biosimilar medication is selected. Finally, in addition to a couple of other nuances, it removes the requirement of the generic substitution signage (The Travis S section.)

And last but certainly not least!

HB 740 – An act generally revising laws relating to pharmacies, pharmacy benefit managers, and other entities – PASSED! This bill was brought forth by Montana Family Pharmacies and MPA was proud to help get this across the finish line. There will be a lot more to come on this effort (and lawsuits are expected) but a 10,000 ft summary of this bill states that independent pharmacies in Montana will be reimbursed on a cost+ model (NADAC + dispensing fee) to include a \$15 dispense fee. This is the most comprehensive bill passed in the US to protect patients' access to their local pharmacy. We are still hoping to work with the Governor's office to have a bigger spotlight on this effort but this was one of if not the most contentious bills heard during the session. What was passed is a credit to everyone that helped. MPA came through when asked and it cannot be understated that it took everyone to get this passed. A heartfelt thank you to everyone!


